- 3. The Registrar was acknowledged as the Committee's Secretary.
- 4. The Registrar's Office updated the Committee on approved absence requests and updated the committee on recent activities. With classes having gone online in Spring and Summer and with Fall 2020 including online, residential, and hybrid delivery modes, the questions on excused absences have taken a different path. If all a student's classes are online, for example, would an excused absence be necessary and, if so, what information would need to be gathered is the question at hand now. The Committee will circle back to this at a future meeting.

- 5. Committee members discussed possible agenda items for this year. The following items were mentioned with follow-up as noted.
 - a. SGA and faculty senate endorse support of election day accommodations. Students to submit voting request absence form to registrar's office.
 - b. Graduate student stipends was an important topic last year. Kate will follow up with Dr. Ferri to determine the current status of any current proposals. One potential piece of unfinished business is the transparency of stipend information about the academic unit and graduate studies levels.
 - c. Student participation in national championships or Olympic events was discussed last year without any policy or guidance being approved. This should be revisited to determine if action needs to be taken.
 - d. Textbook affordability project was introduced last year. Kate will ask Colin Potts for an update.
 - e. Potential agenda item for this year: financial impact of COVID on students. Dean of Students offers a hardship fund of \$1000.
- 6. The Registrar will send a Doodle poll to determine some possible meeting dates for Oct., Nov., and possibly Dec. to finish out the Fall term.
